

VANCOUVER 26™ MATCH TICKET INVITATION DRAW—PERIOD 2

The Vancouver 26™ Match Ticket Invitation Draw—Period 2 (the “**Contest**”) is brought to you by Level the Field viaSport Foundation (the “**Foundation**”). By participating in this Contest, each entrant acknowledges compliance with, and agrees to be bound by, these Contest rules (these “**Rules**”).

1. **Eligibility.** The Contest is open to only individuals who are legal residents of British Columbia or Yukon, Canada and who have reached 19 years of age at the time of entry. Individuals who are residents of any other province or territory in Canada (including Quebec) are not eligible to enter. The Draw is not open to: (a) employees, officers, or directors of the Foundation, viaSport British Columbia Society, BC Pavilion Corporation, FIFA World Cup 26 Vancouver Host Committee, the Government of British Columbia’s Ministry of Tourism, Arts, Culture and Sport, or Fédération Internationale de Football Association (“**FIFA**”), or their respective subsidiaries, affiliates, or advertising or promotional agencies; or (b) any spouse, parent, sibling, child, or person residing in the same household as an individual referred to in section 1(a) of these Rules.
2. **Contest Dates and Times.** The Contest begins at 10:00 a.m. (Pacific Time) on January 23rd, 2026 and ends at 5:00 p.m. (Pacific Time) on March 3rd, 2025 (that period, the “**Contest Period**”), after which time the Contest will be closed and no further entries accepted.
3. **How to Enter.** You may enter the Contest in one of two ways: (a) by accessing the donation form available online at <https://www.canadahelps.org/en/dn/143022> and by using that donation form to complete a non-anonymous donation to the Foundation of at least CAD\$26 within the Contest Period; or (b) by writing a short (100 words or less) signed letter stating your wish to enter the Contest, including your full name, mailing address, phone number, and email address (which contact details will not be included in the word count for the letter), and mailing or delivering the letter to the following address during the Contest Period:

Limit one entry per individual during the Contest Period. All entries must be complete and are subject to verification by the Foundation, in its sole discretion. Duplicate or automated entries (including entries submitted via bots, scripts, or third parties) are prohibited and void. Entries that are late, lost, stolen, illegible, contain false information, damaged, misdirected, incomplete, altered, or otherwise irregular, or that do not conform with or satisfy any the conditions of these Rules, are void. Proof of transmission (for example, screenshots or captures) does not constitute proof of entry or receipt of an entry.

4. **Prizes.** There are a total of 16 prizes, each consisting of two invitations to attend a designated FIFA World Cup 26™ group stage match at BC Place (777 Pacific Boulevard, Vancouver, BC V6B 4Y8). Approximate retail value of each prize is \$400 (as at January 23rd, 2026). Prizes must be accepted as awarded and have no cash value. The Foundation reserves the right, in its sole discretion, to substitute an alternate prize of equal or greater value if an advertised prize is unavailable at the time of award. An awarded prize may not be sold, resold, or otherwise transferred; any such disposition is strictly prohibited, void, and may result in cancellation of the prize without compensation. All incidental costs and expenses not specifically referred to herein including (without limitation) federal, provincial and local taxes shall be the responsibility of a winner.

5. **Odds of Winning.** The odds of winning depends on the number of eligible entries received during the Contest Period.
6. **Winner Selection and Prize Award.** On March 5th, 2025 at 11:00 a.m. (Pacific Time), at the Foundation's address under section 3 of these Rules, the Foundation, or an employee, agent, or other representative of the Foundation, will conduct a random draw from all eligible entries received during the Contest Period and select potential winners (each, a "**Selected Entrant**"). A Selected Entrant will be notified within seven days of the random draw and will be contacted by phone or e-mail provided at the time of entry. Up to three attempts will be made to contact a Selected Entrant within five days following the random draw. A Selected Entrant that cannot be reached as aforesaid may be forfeited in the Foundation's sole discretion. If the entry of a Selected Entrant is deemed void for any reason or if a Selected Entrant is forfeited for any reason, does not meet the eligibility criteria, or does not or cannot accept a prize (including as a result of failed delivery of return of a prize), such Selected Entrant will be disqualified and will not receive a prize, and another entrant will be selected by way of a random draw from the remaining eligible entries.

Before being declared a winner, a Selected Entrant must: (a) correctly answer, without assistance, the Foundation's time-limited, mathematical skill-testing question, to be administered by phone; (b) sign and return a Declaration, Release, and Waiver (a "**Winner Release**"), as described in section 7 of these Rules, within seven days of the Selected Entrant's receipt thereof from the Foundation; and (c) comply with all provisions of these Rules. A Selected Entrant will be deemed a winner if they meet all of the eligibility criteria and conditions set out in these Rules.

If the identity of a Selected Entrant is disputed, the entry will be deemed to have been submitted by the individual assigned to the email address provided with the entry. A Selected Entrant may be required to provide proof that the Selected Entrant is the individual assigned to the email address associated with a selected entry.

7. **Release and Indemnification.** Before being declared a winner, a Selected Entrant must sign a Winner Release in the form provided by the Foundation to: (a) confirm compliance with these Rules; (b) agree to accept prizes as awarded; (c) release, discharge, and hold harmless the Foundation, FIFA, their respective departments and agencies, parent, related, and affiliated corporations, subsidiaries, franchisees, advertising and promotional agencies, counsel, marketing partners, and each of their respective directors, officers, employees, shareholders, successors, sponsors, partners, licensees, subsidiaries, agents, artists, advisors, assignees, and all others associated with the administration, development, or execution of the Contest (collectively, "**Released Parties**") from and against: (i) any and all manner of actions, causes of action, suits, demands, proceedings, and claims (whether for injuries, losses, damages, interest, costs, fines, penalties, legal fees and expenses, or otherwise, including claims based on negligence, breach of contract, or fundamental breach); (ii) use or misuse of a prize or any travel related thereto; (iii) the use of the Selected Entrant's entry by the Foundation; (iv) failure of any third-party contractor or supplier used in connection with any aspect of the Contest to perform or deliver any goods or services; (v) any act of God or any other event beyond any one or more of the Released Parties' control; (vi) any dissatisfaction of any kind by the Selected Entrant with any aspect of the Contest or any prize; and (vii) liability for physical injury, death, or property damage which the Selected Entrant, a guest, or their respective personal representatives or heirs have, might have, or could have suffered, by reason of or arising out of the Selected Entrant's participation in the Contest or in connection with the acceptance or exercise by the Selected Entrant of a prize as awarded;

and (d) indemnify and save the Released Parties from and against any loss, cost, liability, claim, interest, fine, penalty, assessment, damage (including indirect damages or loss of goodwill) or expenses including reasonable costs, fees, and expenses of legal counsel on a full indemnity basis (without reduction for tariff rates or similar reductions) and reasonable costs, fees and expenses of investigation that any one or more of the Released Parties may suffer or incur as a result of any non-compliance by the Selected Entrant with any of these Rules, participation in the Contest, or in connection with the acceptance or exercise by the Selected Entrant of a prize, and the use of entries by the Foundation.

The Released Parties are not responsible for: (e) incorrect or inaccurate entry information that may affect an individual's ability to participate in the Contest or be awarded a prize, including but not limited to human error, technical malfunctions, lost or delayed entries for any reason, mail failures, omission, or any combination thereof, and entries that fail to fully comply with these Rules; (f) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (g) late, lost, stolen, illegible, false, damaged, misdirected, incomplete, altered, or otherwise irregular entries or Winner Releases, or entries or Winner Releases that do not conform with or satisfy any or all of the conditions of these Rules; (h) injury or damage to entrants' computers or to any other person's computer related to or resulting from participating in, or downloading any material regarding the Contest or accepting a prize; (i) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from any entrant's participation in the Contest or receipt or use or misuse of any prize, including any related travel and the use of entries by the Foundation; (j) the security or privacy of information transmitted via computer networks or for breaches of privacy due to interference by third-party computer hackers or otherwise; or (k) late, lost, misdirected or unsuccessful efforts to notify or to receive a response from a Selected Entrant.

8. **Change or Termination.** The Foundation may, its sole discretion, terminate or amend the Contest or the Rules in any way, and for any reason, without prior notice or liability to any entrant. The Foundation is entitled to make all final decisions in relation to the Contest, and those decisions are final and binding on all entrants without right of appeal.
9. **Privacy and Publicity.** By participating in the Contest, each entrant, without further notice or compensation: (a) expressly consents to the use of the entrant's name, name, address, email address, phone number, social media handles, comments, likeness, and image, in any medium (collectively, the "**Content**"), for the administration of the Contest in accordance with the Foundation's privacy policy found at <https://viasport.ca/wp-content/uploads/2025/01/Privacy-Policy.pdf>; and (b) agrees to participate in any activity relating to the random draw for the Contest or promotion or publicity of the Foundation, and irrevocably grants and licenses to the Foundation the right to alter and use, and to permit others to use, the Content for the purpose of those activities, in perpetuity worldwide.
10. **Governing Law.** The Contest is void where prohibited by applicable law. The Contest and these Rules, and all matters related thereto, are governed by the laws of the Province of British Columbia and the federal laws of Canada applicable therein, without giving effect to any choice of law or conflict of law rules. All disputes will be resolved in the courts of the Province of British Columbia.
